FOREWORD

Created in 2012, the OP3FT (Organization for the Promotion, Protection, and Progress of Frogans Technology) is a *Fonds de dotation* governed by French Law n°2008-776 of August 4, 2008 on the Modernization of the Economy.

The OP3FT is a non-profit organization acting in the public interest. Its purpose is to hold, promote, protect and ensure the progress of the Frogans technology, in the form of an open standard for the Internet, available to all, free of charge.

The OP3FT Bylaws were registered at the *Préfecture de Paris*, France, on February 21, 2012. The declaration of creation of the OP3FT was published on March 17, 2012 in the *Journal Officiel des Associations et Fondations d'Entreprise* of the French Republic (JOAFE n°11) under number 1540.

The OP3FT Bylaws were updated three times:

- on July 28, 2016. The amendment to the Bylaws corresponding to this update was filed with the *Préfecture de Paris*, France, on September 5, 2016. The declaration of this amendment to the OP3FT Bylaws was published in the *Journal Officiel des Associations et Fondations d'Entreprise* of the French Republic (JOAFE n°40) on October 1, 2016 under number 2076.
- on January 16, 2021. The amendment to the Bylaws corresponding to this update was filed with the *Préfecture de Paris*, France, on January 25, 2021. The declaration of this amendment to the OP3FT Bylaws was published in the *Journal Officiel des Associations et Fondations d'Entreprise* of the French Republic (JOAFE n°15) on April 13, 2021 under number 1460.
- on August 23, 2021. The amendment to the Bylaws corresponding to this update was filed with the *Préfecture de Paris*, France, on August 31, 2021. The declaration of this amendment to the OP3FT Bylaws was published in the *Journal Officiel des Associations et Fondations d'Entreprise* of the French Republic (JOAFE n°37) on September 14, 2021 under number 1749.

The OP3FT's registered office is located 27-29 rue Raffet, 75016 Paris, France

The OP3FT was created with an initial endowment granted free of charge and irrevocably by its Founder, the company STG Interactive S.A. The OP3FT's endowment is non-expendable and inalienable. Properties and rights composing the endowment are non-transferable and intangible.

The initial endowment of the OP3FT includes properties and rights relating to the Frogans technology, notably languages, technical specifications, software development systems, software source code, trademarks, patents and domain names, as well as the related intellectual property rights. It does not include any securities nor monies.

The OP3FT is an operational endowment fund. The OP3FT carries out work to fulfill its public-interest mission in relation to the Frogans technology. This work, described in detail in Article 5 of the OP3FT Bylaws, is carried out under the responsibility of a permanent working team within the OP3FT.

The OP3FT refrains from any for-profit activity, even on an accessory basis. The OP3FT's resources for the financing of its public-interest mission are constituted by the revenues of its endowment and by any lifetime gifts that might stem from public generosity.

In accordance with the OP3FT Bylaws, the endowment revenues are exclusively derived from the operating license granted by the OP3FT to the Frogans Core Registry Operator (FCR), under a delegation agreement.

This Activity Report covers the twelfth accounting period of the OP3FT, from January 1, 2023 to December 31, 2023. During this accounting period of 12 months, the OP3FT (i) did not make any reallocations as defined under Article 140 of the August 4, 2008 French Law, (ii) did not receive any donations, and (iii) did not receive any lifetime gifts stemming from public generosity.

In accordance with the OP3FT Bylaws, this Activity Report lays out, in addition to the information required by French laws and regulations, the properties and rights assigned to the increase of the endowment over the past year, and the details of resources originating from the endowment revenues.

This Activity Report was approved by the OP3FT Board of Directors on June 27, 2024. In accordance with Article 24 of the OP3FT Bylaws, the Activity Report was finalized then approved at the same time as the finalization and the approval of the Annual Financial Statement.

I. INTERNAL OPERATIONS OF THE OP3FT

I.1. REMINDER OF THE PURPOSE OF THE OP3FT

The OP3FT is a non-profit organization created on March 17, 2012 whose purpose is to hold, promote, protect and ensure the progress of the Frogans technology, in the form of an open standard for the Internet, available to all, free of charge.

More generally, the OP3FT's purpose is to contribute to the development of a secure and stable Internet that is open to innovation, and to support and finance innovative public-interest initiatives or actions of a social, educational or cultural nature in the area of information and communications technologies.

The Frogans technology is the foundation of Frogans, the new medium for publishing content and services on the Internet in the form of Frogans sites. From a technical standpoint, this medium is designed as a new generic software layer running on top of the original Internet infrastructure, alongside other existing software layers such as E-mail or the World Wide Web.

A Frogans site is a new kind of online site founded on a new format. Each Frogans site is made up of free-form pages called Frogans slides which are interconnected. Each Frogans site is accessible via its Frogans address.

In a manner comparable to the development of the World Wide Web from the 90s, the OP3FT's aim is that an ecosystem flourish on top of the Frogans technology, fostering employment, innovation and economic development, in the public interest.

I.2. BOARD OF DIRECTORS

All members of the OP3FT Board of Directors are natural persons, carrying out their duties as Director in a personal capacity and without receiving a financial counterpart.

The Directors act in an independent and neutral manner with respect to special interests, including those of legal entities in which they might hold a position, whilst respecting the founding principles defined in the OP3FT Bylaws.

As of December 31, 2023, the OP3FT Board of Directors was composed of four Directors:

- Mr Amaury GRIMBERT,
- Mr Alexis TAMAS,
- Mr Alain MARTEL,
- Mr Khaled KOUBAA.

The President of the Board of Directors is Mr Amaury GRIMBERT.

Between January 1, 2023 and December 31, 2023, the OP3FT Board of Directors met 13 times at the registered office or via videoconference: on January 25, February 21, March 27, April 24, May 29, June 20, September 7, October 5, October 23, October 31, November 18, November 27, and December 19, 2022.

The main decisions of the OP3FT Board of Directors notably covered:

- work in view of the start of the Beta period of the Frogans technology;
- to develop a proof of concept as regards the use of Frogans sites in a VR/AR environment;
- to have the OP3FT team participate in the Viva Technology (VivaTech) 2023 event in Paris to present demonstrations of the Frogans technology on computers, mobiles and in VR/AR;
- to have OP3FT China launch a new *Projet d'Innovation Collaborative* (Collaborative Innovation Project) with École Centrale de Pékin for the academic year 2023-2024;
- to protect the rights of the OP3FT for the "Frogans Star" figurative trademark;
- the global amendments to the base gTLD registry agreement proposed by ICANN;
- the renewal by ICANN (Internet Corporation for Assigned Names and Numbers) of the delegation to the OP3FT of the ".frogans" gTLD;
- to grant to the company F2R2 a new extension for payment of the monthly royalties due under the license to operate the FCR, as an exceptional measure in the tense international context related, notably, to the war in Ukraine that has a negative effect on the pace of fundraising by the company F2R2;
- to prepare an application to be submitted to the *Préfet de Paris* in order to obtain a new authorization to call on the generosity of the public;
- to approve the Annual Financial Statement of OP3FT Branches for the year 2022;
- to contribute new tranches of the share capital of the local branch of the OP3FT in China, "OP3FT China", by the sole shareholder of OP3FT China, "OP3FT Branches";

- to renew the mandate of Mr Alain MARTEL in his capacity as Director;
- to renew the mandate of Mr Amaury GRIMBERT in his capacity as President;
- to finalize, approve and publish the Annual Financial Statement and Activity Report for the year 2022.

In 2023, the OP3FT Board of Directors did not engage in the public consultation process referred to in Article 13 of its Bylaws, since the Frogans Core Registry was not yet open to Internet users.

As of December 31, 2023, the Rules of Procedure of the OP3FT were in the process of being drawn up by the Board of Directors.

I.3. INVESTMENT COMMITTEE

According to Article 18 of the OP3FT Bylaws, "The Investment Committee shall be composed of two to five members, appointed by the Board of Directors for a three-year term, renewable by periods of three years, without limitation."

On December 31, 2023, both Investment Committee members, who are qualified in financial management and who do not receive any remuneration for carrying out their duties, are:

- Mr Erik POINTILLART,
- Mr Benoît REDON.

Their mandate was renewed on September 23, 2022 for a period of three years, i.e. until October 24, 2025. The Investment Committee did not meet during 2023.

It is here restated that the OP3FT's endowment does not include any securities nor monies.

I.4. OTHER COMMITTEES

According to Article 4 of the OP3FT Bylaws, "the OP3FT's purpose is to contribute to the development of a secure and stable Internet that is open to innovation, and to support and finance innovative public-interest initiatives or actions of a social, educational or cultural nature in the area of information and communications technologies."

According to Article 7 of the OP3FT Bylaws, "The Board of Directors may enlist the services of scientific, ethics or audit committees to enlighten or assist the Board in making complex or technical decisions."

In compliance with these two articles, the OP3FT Board of Directors decided, during its meeting on March 28, 2018, to create a "Supported Projects Committee". The mission of the Committee eventually will be to select innovative public interest projects or actions that the OP3FT could finance if its resources should exceed what it needs to fulfill its mission to hold, promote, protect and ensure the progress of the Frogans technology.

The first two members of the Supported Projects Committee were Mr Erik POINTILLART and Mr Benoît REDON. Their mandate, for a period of three years, expired on March 28, 2021.

The OP3FT Board of Directors decided, during its meeting on August 6, 2021, not to immediately renew the Supported Projects Committee, and to review at a later date the opportunity of reactivating it, as soon as the resources of the OP3FT exceed its needs for the fulfillment of its mission to hold, promote, protect and ensure the progress of the Frogans technology.

During the year 2023, the Supported Projects Committee was not reactivated. Nor did the OP3FT create other committees.

I.5. WORK TEAM

The work team formally undertakes to act in an independent and neutral manner with regards to special interests and to respect the founding principles defined in the OP3FT Bylaws.

As of December 31, 2023, the OP3FT work team comprised eight employees and three apprentices. In addition, three specialized independent contractors participated regularly, as well as five regular contributors, including the two Inventors of the Frogans technology mentioned in Article 9 of the OP3FT Bylaws. The total team is made up of nineteen people.

This work team consists of individuals with varied profiles (engineers, legal professionals, etc.), intervening in work related to the promotion, protection and progress of the Frogans technology.

II. DEALINGS WITH THIRD PARTIES

II.1. PARTNERS OF THE OP3FT

During the year 2023, the OP3FT did not engage in any partnerships.

II.2. SERVICE PROVIDERS OF THE OP3FT, INCLUDING LOCAL BRANCHES OF THE OP3FT

Service providers of the OP3FT formally undertake to act in an independent and neutral manner with regards to special interests and to respect the founding principles defined in the OP3FT Bylaws.

During the year 2023, the OP3FT continued to have recourse to service providers participating regularly or occasionally within the work team. The OP3FT service agreement signed with these service providers guarantees, in particular, that the OP3FT fully and completely owns the work carried out by them, so that the OP3FT, by decision of the Board of Directors, can assign such work, in whole or in part, to the OP3FT's endowment.

During the year 2023, the OP3FT pursued its relations with ICANN (the Internet Corporation for Assigned Names and Numbers). ICANN renewed the delegation to the OP3FT of the ".frogans" gTLD for a new 10 year period starting December 19, 2023. The OP3FT also pursued its relations with the company Identity Digital (ex Afiliás) relative to the delegation of the ".frogans" top level domain

(TLD); as well as with the company NCC Group for the data-escrow services that every Registry operator of a TLD must implement.

Moreover, OP3FT China, the local branch of the OP3FT in China created in 2019 in Beijing continued to provide the OP3FT with services concerning the development and the promotion of the Frogans technology in China, as part of a master service agreement signed by the OP3FT and OP3FT China.

The OP3FT also continued its work on setting up a local branch in the United States, "OP3FT USA", in Washington D.C.

As a reminder, in application of Article 22 of the OP3FT Bylaws, "The OP3FT may create and fund local branches of the OP3FT located abroad, set up in the form of a non-profit organization. Local branches of the OP3FT may be created in another form, including that of a commercial organization, for example in the case where it is required by the legislation of the country in question."

Finally, seven specialized service providers (intellectual property practices, lawyers, etc.) participated occasionally in 2023.

III. PUBLIC-INTEREST ACTIONS CARRIED OUT BY THE OP3FT

As an operational *Fonds de dotation*, the work that the OP3FT must carry out in the public interest, under the supervision of the Board of Directors, is detailed in Article 5 of its Bylaws.

During the year 2023, work carried out by the OP3FT in order to hold, promote, protect and ensure the progress of the Frogans technology, mainly focused on:

- the general organization of the OP3FT's work in the long term;
- the development of the main, complementary and inseparable components of the Frogans technology;
- the drawing up and updating of the OP3FT's policies;
- the organization of work in view of the start of the Beta period of the Frogans technology;
- the continuation of the project for creating a local branch of the OP3FT in the United States, "OP3FT USA";
- the development of the local branch of the OP3FT in China, "OP3FT China";
- the rollout of a new *Projet d'Innovation Collaborative* (Collaborative Innovation Project) with École Centrale de Pékin for the academic year 2023-2024, after those which were successfully completed each year since the academic year 2018-2019, covering the development of advanced human-computer interactions using Frogans as a medium;
- the ongoing promotion of the Frogans technology aimed at Internet entrepreneurs by way of operations worldwide, and particularly in China, with OP3FT China renewing its membership with the Internet Society of China (ISC) as of the month of July 2023, and the participation of OP3FT China in two events held by ISC, namely the China Internet Conference from July 18 to 20, 2023, and the ninth annual conference on the rule of law on the Internet in China on October 31, 2023, and the participation of the OP3FT in the 2023 Hong Kong Arbitration Week organized by the Hong Kong office of ADNDRC (Asian Domain Name Dispute Resolution Centre) from October 16 to 20, 2023;

- the promotion of the Frogans technology in cooperation with the company F2R2, notably the design and development of demonstration Frogans sites and the participation in the VivaTech event from June 14 to 17, 2023;
- the drawing up and publication of legal resources on “fcr.frogans”, the Web site of the FCR Operator;
- the management of the “.frogans” top level domain (TLD) with ICANN (Internet Corporation for Assigned Names and Numbers), the company NCC Group and the company Identity Digital (ex Afiliias);
- the management of the OP3FT’s trademarks, patents and domain names;
- the management of the OP3FT’s Web sites, including “op3ft.org”, “frogans.org”, “donate.op3ft.org”, “china.op3ft.org”, and “usa.op3ft.org”, and of the Frogans technology mailing lists, including the read-only mailing list “announcement@lists.fcr.frogans”.

While carrying out work in relation to the Frogans technology, the OP3FT made sure that the provisions of Article 5 of its Bylaws were respected.

More particularly, in the choices it made while carrying out work in relation to the Frogans technology, the OP3FT endeavored to include a clear statement (“rationale”) presenting the reasoning behind said choices. On the publication date of this Activity Report, all the Board meeting minutes for the years 2012 to 2021 have been published, in French, on the OP3FT’s Web site “op3ft.org”, as well as their translations in English. For the year 2022, the minutes of the Board of Directors meetings until May 9 were published. The minutes of the following meetings are in the process of being published.

In accordance with its Bylaws, the OP3FT carried out work in relation to the Frogans technology according to the financial and human resources at its disposal in 2023.

IV. PUBLIC-INTEREST ACTIONS LED BY THIRD PARTIES AND FINANCED BY THE OP3FT

During the year 2023, the OP3FT did not finance any innovative public-interest initiatives or actions led by third parties, as it had used all available resources to finance work carried out to ensure its public-interest mission in relation to the Frogans technology.

V. LEGAL ENTITIES BENEFICIARIES OF REALLOCATIONS BY THE OP3FT

During the year 2023, the OP3FT did not make any reallocations as defined under Article 140 of the August 4, 2008 French Law, as it had not financed any other public-interest organization.

VI. ENDOWMENT OF THE OP3FT

VI.1. INITIAL ENDOWMENT

In accordance with the OP3FT Bylaws, the OP3FT's endowment is non-expendable and inalienable. Properties and rights composing the endowment are non-transferable and intangible, regardless of whether they were granted at the time of the OP3FT's creation as the initial endowment, or during its lifetime pursuant to an increase of the endowment.

The OP3FT was created with an initial endowment granted free of charge and irrevocably by its Founder. The initial endowment includes properties and rights relating to the Frogans technology, notably languages, technical specifications, software development systems, software source code, trademarks, patents and domain names, as well as the related intellectual property rights.

The complete list of properties and rights composing the initial endowment is given in Annex 2 of the OP3FT Bylaws. The initial endowment does not include any securities nor monies.

The events that took place over the past year covering the properties and rights composing the OP3FT's endowment at the beginning of the year are given in Annex 1 of this Activity Report.

As of December 31, 2023, all concerned national, regional and international offices had processed notices of transfer to the benefit of the OP3FT regarding trademarks, patents and domain names, with the exception, however, of some notices of transfer of trademarks still in course in some countries.

VI.2. INCREASE OF THE ENDOWMENT

In accordance with the OP3FT Bylaws, the endowment is increased, during the OP3FT's lifetime, by properties and rights assigned to it.

The properties and rights created and developed in 2023 by the OP3FT as part of its public-interest mission in relation to the Frogans technology, through its salaried employees and service providers, were assigned to the OP3FT's endowment.

These properties and rights created and developed by the OP3FT as part of its public-interest mission in relation to the Frogans technology and assigned to the increase of the endowment over the past year are listed in Annex 2 of this Activity Report.

Likewise, properties and rights granted free of charge and irrevocably in 2023 by third parties, including by the two Inventors of the Frogans technology, and contributing to the public-interest mission of the OP3FT in relation to the Frogans technology, were assigned to the endowment.

These properties and rights granted free of charge and irrevocably by third parties contributing to the public-interest mission of the OP3FT in relation to the Frogans technology and assigned to the increase of the endowment over the past year are listed in Annex 3 of this Activity Report.

In order not to restrict the conditions of use of the Frogans technology, these third parties, referred

to as “Contributors”, granted free of charge and irrevocably, all and any rights relative to their contributions to the OP3FT, in accordance with the OP3FT Bylaws.

VII. RESOURCES OF THE OP3FT

VII.1. ENDOWMENT REVENUES

In accordance with its Bylaws, the OP3FT refrains from any for-profit activity, even on an accessory basis. Consequently, no revenue from profit-making activities of the OP3FT, nor compensation for services provided by the OP3FT, may be added to its resources.

The OP3FT’s resources for the financing of its public-interest mission are constituted by the revenues of its endowment.

In accordance with the OP3FT Bylaws, endowment revenues are derived exclusively from the operating license granted by the OP3FT to the Frogans Core Registry Operator (FCR), under the delegation agreement.

As of December 31, 2023, endowment revenues of the OP3FT derived from the Frogans Core Registry operating license granted by the OP3FT to the Operator amounted to 1,800,000 euros, recorded as “*Revenus de la dotation*”.

By way of a decision taken by the Board of Directors on May 29, 2023, the OP3FT granted, as an exceptional measure, to the company F2R2 new delays for the monthly royalties payments, given the difficulties the company F2R2 has encountered in raising funds in the tense international context related, notably, to the war in Ukraine, and given the lack of other possible resources for the company F2R2.

The company F2R2 is based in France. The OP3FT does not receive funding stemming from countries other than France.

VII.2. USE OF RESOURCES

In accordance with its Bylaws, the OP3FT’s resources are used to finance work carried out to fulfill its public-interest mission in relation to the Frogans technology, as well as the OP3FT’s expenditures for day-to-day management.

As of December 31, 2023, the OP3FT had the ways of using its resources described in parts I and II of this Activity Report. These ways include, in particular, hiring salaried employees and calling on service providers, renting premises and purchasing equipment.

As of December 31, 2023, the OP3FT’s operating costs amounted to 830,789 euros, of which 200,415 euros concerned calling on service providers (“*Services extérieurs*” and “*Autres services extérieurs*”) and 604,209 euros concerned salaried employees (“*Salaires et traitements*” and “*Charges sociales*”).

“*Services extérieurs*” and “*Autres services extérieurs*” mainly include: services provided in relation

to work carried out to promote and protect the Frogans technology (intellectual property expenses for trademarks, patents and domain names, expenses related to the organization of the OP3FT's work, recruitment and human resources management costs), services provided in relation to work carried out to ensure the progress of the Frogans technology (software development and drawing up of technical specifications), premises rental expenses, including the OP3FT's registered office, as well as services provided in relation to social and accounting matters and to the auditing mission of the Statutory Auditor.

As of December 31, 2023, the net result was 972,170 euros.

As of December 31, 2023, the OP3FT had used all the resources it received during the accounting period, so that the provisions of Article 22 of the OP3FT Bylaws concerning unused resources do not apply.

VII.3. STATEMENT OF UTILIZATION OF FUNDS

The OP3FT obtained authorization to call on public generosity from March 16, 2023 to December 31, 2023, by way of a prefectural ruling dated May 15, 2023. The OP3FT has not drawn up a statement of utilization of funds for the accounting period, since it did not receive in 2023 any lifetime gifts stemming from public generosity.

VII.4. BOUNTIES

During the year 2023, the OP3FT did not receive bounties, such as donations or bequests.

VIII. ANNUAL FINANCIAL STATEMENT

The Statutory Auditor of the OP3FT is the firm 3A CONSEIL (34 rue de Liège, 75008 Paris, France) represented by Mrs Sabrina MERNICHE.

The Chartered Accountant of the OP3FT is Cabinet HYART, represented by Mr Frédéric HYART (7 rue du Four St Jacques, 60200 Compiègne, France).

The OP3FT has prepared a financial statement, which includes a balance sheet, a revenue and expenses statement and a table of subsidiaries and affiliates for its twelfth accounting period beginning on January 1, 2023 and ending on December 31, 2023.

The Annual Financial Statement for the accounting period ending December 31, 2023 was finalized by the Board of Directors on May 6, 2024.

The Statutory Auditor's report is dated June 26, 2024. The OP3FT's Annual Financial Statement 2023 was approved by the OP3FT Board of Directors on June 27, 2024.
